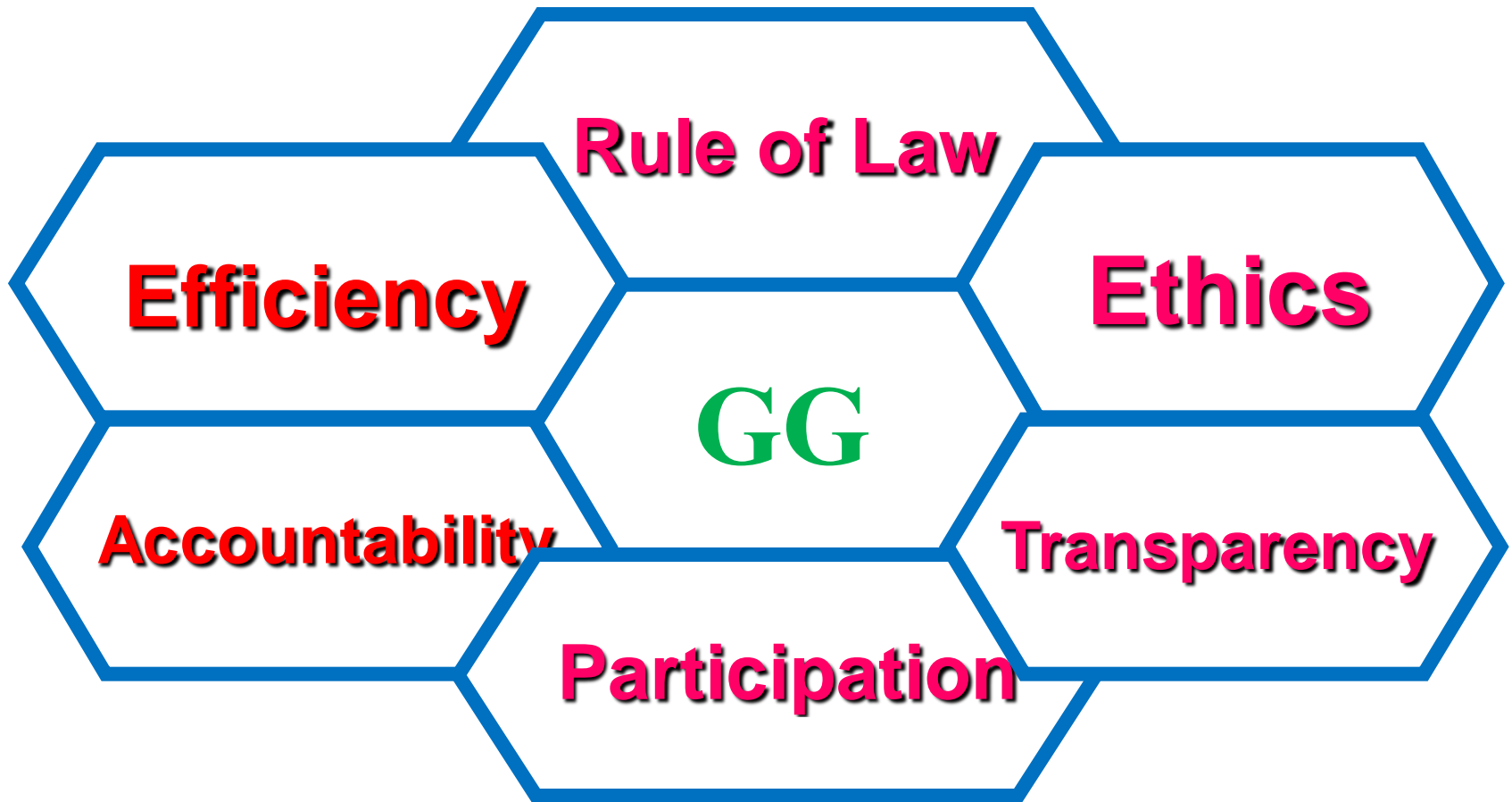

- 2. Improve Local personnel administration and strengthen capacity of Local personnel**

Mission of DLA

- 3. Develop effective budget execution and accounting system of LGOs**
- 4. Promote and develop management system of LGOs to achieve goal of good governance and be able to deliver standardize public service for local people**

Mission of DLA

- 5. Promote and develop integrate management of LGOs in term of Infrastructure development,land use planning , natural resource and environmental conservation**
- 6. Support community-base organization to participate in development process with LGOs and to follow concept of sufficiency economy**

Strategies

- **Strengthen capability of LGOs in term of management that response to people, more effective and integration process**
- **Develop supervision system by people and promote more public participation**

Duties of DLA to promote Local Governance

- 1. Develop system and structure of LGOs**
- 2. Promote and support process of comprehensive planning for LGOs , set up system to monitor and evaluate implementation of LGOs development plan**
- 3. Enact and amend law and regulation about Local authority and supervision of LGOs in delivering public service**

Duties of DLA to promote Local Governance

- 4. Set up guideline and general standard of Local personnel administration stipulate by law**
- 5. Promote, support and coordinate implementation of LGOs in term of finance, budget preparation, procurement, revenue collection system and local enterprise, Include set up system to inspect LGOs.**
- 6. Promote, support and coordinate public service delivery and education management implement by LGOs**

Duties of DLA to promote Local Governance

- 7. Set up guideline, system and standardize indicator for LGOs in delivery public services include supervise LGOs to do task follow that standard**
- 8. Promote people participation and inspection in the implementation of LGOs**
- 9. Develop management information system of LGOs**
- 10. Training and development of Local personnel and DLA personnel**

Initiatives of DLA

1. Law Amendment ; Local Act about GG
2. Public Participation Promotion
;Planning,Implementation,Evaluation,supervision
3. Supervision of LGOs in drafting Local Ordinances
4. Enact Ministry Regulations ; Local Planning,
Procurement,Council Conference,Budget preparation
5. Set up Standard of Public service delivery 48 items

Initiatives of DLA (continue)

6. Set up central standard of supervision as guideline which shall be applied by the local government organization, upon their own selection (constitution of Thailand section 282)
7. Reward for prominent LGOs ; incentive for management in term of GG principles (since 2003 but now is in responsible of DLOC)
8. Set up performance agreement for DLA personnel that promote Local Governance of LGOs ; e.g. community plan integrate to local plan
9. Reduce complaint from people about LGOs administration
10. Set up inspection process in Internal audit of LGOs
