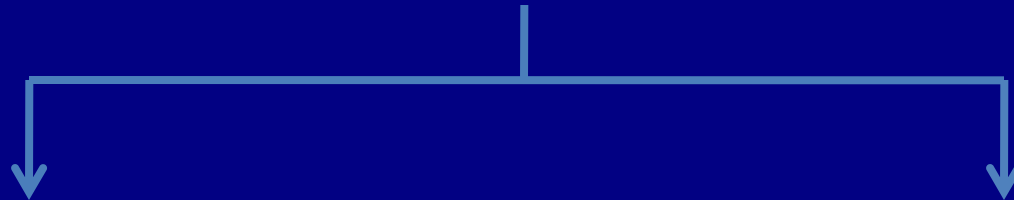

Grant funding mechanism

Call for Proposals – a mechanism whereby a selection process is launched to choose projects on a competitive (non-discriminatory) basis

There are 2 types of procedure:

- Restricted - concept note and full application
- Open - full application
